On March 5, Comptroller for the State of Maryland Brooke Lierman visited SHORE UP to discuss how our VITA tax program is running and to tell us about Maryland's Direct File. Taxpayers with internet access who are comfortable completing forms online can use Direct File to prepare and electronically file their tax returns online, for free, directly with the government. Taxpayers who need some assistance, aren't tech savvy, or would prefer that someone with official training do them, can still utilize our VITA tax program.

First place entry — Arionah Abney:

"... the children I teach are the future. They are the next generation of leaders, innovators, caregivers, and citizens. The foundation I help provide today will shape the world they build tomorrow. I take this responsibility seriously, knowing that the skills, values, and sense of self I help instill in them will echo throughout their lives and the lives of those they impact. It's not just about teaching children to read, write, or count—it's about helping them grow into kind, empathetic, resilient individuals who can contribute positively to society."

Second place entry—Tamara Osborne:

"... being a teacher is like farming:

I must build trust with that child so we can have a solid relationship.
Farmers must till the land to prepare the soil for the foods.



- I had to use my skills as well as teaching tools to plant the seeds of learning in their minds. Farmers use machines to plant the seed in the ground.
- I must nurture my children daily with love, kindness, and patience so they can grow and hit their milestone developments. Farmers must ensure the plants have enough water and sunlight to grow.
- When I see challenging behavior, I do the best I can to try to eliminate it or have it down to a minimum. Much like the farmers who must ensure that no weeds grow with the plants because it can take the nutrients from the plant which are required for them to grow.

I am the one who plants the seed of education in their brain. From the moment they step into my classroom, they will be in school for the next 14 years. That is a long time. My goal is to plant the seed of learning is fun so that on the days when it gets hard or frustrating, they can look back and realize that the hard days don't last long, and good days are soon to follow."
